MAMSS is a professional organization established in 1979 in the State of Minnesota. MAMSS is an independent, non-profit association for Medical Staff Service Professionals throughout Minnesota. One of the key areas where we serve the medical community is through credentialing of medical providers. Credentialing provides a standard for recognizing the provider qualifications and validating broadbased knowledge of these professionals to ensure quality of health care to those they serve. We had 32 members in 1980. Today, we average over 220 members of medical staff and provider credentialing professionals. In 1991 the Northern Region of MAMSS was established and 1994 the Southern Region, and in 2011 the Central and Metro were organized to enhance the networking form for MAMSS members and to increase the opportunities for educational seminars while minimizing travel requirements.


# New MN Uniform Facility Application

### Healthy Sriracha Shredded Chicken Tacos

Total Time 30 minutes Servings 6 Tacos Calories 128kcal

#### Ingredients:

2 thinly sliced chicken breasts 2 Tbsp Sriracha 6 corn tortillas 1 cup chopped red cabbage 1/2 cup chopped peppers 1/4 cup feta cheese 1 lime

# Credentialing and Privileging: Verifying Practitioner

Identification: The Joint Commission recently published this FAQ on Verifying Practitioner Identity

#### Medical Staff (MS) (Hospital and Hospital Clinics / Hospitals)

Credentialing and Privileging - Verifying Practitioner Identification What are the requirements for verifying practitioner identification?

The Joint Commission requires that organizations verify the identity of the individual seeking privileges by viewing one of the following:

- A current picture organizational ID card
- · A valid picture ID issued by a state or federal agency (for example, a driver's license or passport)

The verification is required to be conducted onsite at the organization, except for telemedicine/tele-interpretive service providers where the verification may be completed offsite at the distant location. The verification may be done at any point that the applicant enters the organization, For example:

- · To pick up the application
- · For an interview by the department chair
- When arriving to first provide services
- · When having their photo ID badge picture taken

For organizations consisting of multiple settings, the verification may be conducted in any setting that falls under the scope of the accreditation survey. Once the verification has been made, a notation should be entered into the credentials file, such as on the documents checklist, etc. If the verification is performed at a remote location from the main hospital, then the confirmation of the verification should be forwarded to the credentialing office for inclusion in the credentials file.

It is <u>NOT required or recommended</u> that a copy of the photo ID be taken or placed in the credentials files due to potential for identity theft. Having only a copy of the photo, or a notarized document indicating the identity was verified by another entity would not satisfy the requirement for verification. As noted, the only exception is for the telemedicine/tele-interpretive service providers.
